

# ACTION PLAN of 2015-2016



## Russian Union of Industrialists and Entrepreneurs (RSPP)

### Union of Chambers and Commodity Exchanges of Turkey (TOBB)

Wishing to contribute within the framework of their responsibilities to the development of the commercial and economic relations between Russian Federation and Republic of Turkey; and in accordance to their Agreement on Cooperation signed on June, 18, 2015, Russian Union of Industrialists and Entrepreneurs (RSPP) and Union of Chambers and Commodity Exchanges of Turkey (TOBB), hereinafter referred as "Parties" respectively, within the limits of their power, competence and means, and in accordance with international rules and norms,

#### Have agreed to:

- 1. Take the necessary measures, in order to strengthen mutual investment, commercial and economic cooperation among their business circles.
- 2. Regularly exchange information on their economies, current commercial and economic regulations, investment and co-operation opportunities, tenders, fairs and business opportunities so as to improve the cooperation among their members.
- 3. Seek opportunities to arrange meetings/seminars/roundtables till the end of 2016, including;

- A Turkey-Russia Roundtable Meeting on the sidelines of International Cooperation Platform (ICP), 9-11 December 2015, Istanbul,
- A Roundtable parallel to SPIEF 2016
- ↓ Turkey-Russia Economy Day on a mutually agreed theme and modality,
- ♣ B2Bs & Meetings on topics of mutual interest, if interest is generated by companies of both parties, such as:
  - Food & Food Processing Agricultural Production
  - Automotive and Automotive Spare Industry
  - Machinery Production and Spare Parts
  - Investment Forum in Istanbul/Moscow

- 4. Seek opportunities to organize Regional/Sectoral Matchmaking Programs to foster bilateral relations.
- 5. Support matchmaking efforts of the Russian and Turkish business communities on the regional and sectoral levels.
- 6. Exchange information on economic and legal issues relevant for trade, economic and investment cooperation.
- 7. Undertake initiatives related to the achievement of the objectives stated in the Agreement on Cooperation between RSPP and TOBB and this Action Plan.
- 8. Start discussions on potential coordination and cooperation on SME-related issues through the newly established World SME Forum.
- 9. Coordinate and cooperate within multilateral fora, such as B20 and other international and regional institutions.

This Action Plan signed on September 4, 2015 in Ankara by mutual consent of the parties and written notification.
