Other quotes of interest from G20 communiqué:

- ICTs/Digital: “no country should conduct or support ICT-enabled theft of intellectual property (...) with the intent of providing competitive advantages to companies or commercial sectors. All states in ensuring the secure use of ICTs, should respect and protect the principles of freedom from unlawful and arbitrary interference of privacy, including in the context of digital communications.”  
*B20 also developed a policy paper on the digital economy.*
- SDGs: G20 to “develop an action plan in 2016 to further align work with the 2030 SDG agenda”.
- Integrity: “we endorse G20 High-Level Principles on Integrity and Transparency in the Private Sector”
- COP21 “we will instruct our negotiators to engage (...) in order to arrive at Paris with a way forward.
- Energy “we endorse the G20 Energy Access Action Plan”.
