Today relations between the EU countries and Russia are complicated. The political crisis that has been under way since 2014, has led to unprecedented tensions in the region and caused considerable damage to trade and economic cooperation between traditional partners, as the sharp steps taken did not take real national interests into account. At the same time the sanctions pressure does not lead to political goals achievement, but only contributes to further escalating tensions in relations, reducing competitiveness and depriving the parties and their partners of possible cooperation benefits.

Under the current circumstances, it is especially important to concentrate efforts, if not on strengthening relations between the countries of the region, but on identifying potential opportunities for constructive interaction and establishing mechanisms for restoring cooperation in separate areas. It is also necessary to identify key points of contact that could later become the cornerstones of mutually beneficial and fair cooperation reflecting the interests of the authorities, society and business in the region. A special issue of the above mentioned processes is reinforcement of a dialogue between EU and EAEU as two flagship integration associations, on cooperation of which stability and well-being of people in Greater Eurasia depend.

The Roundtable: "Prospects for the EU – EAEU Common Economic Space: Challenges and Opportunities for Business" aims debate the opportunities and prospective spheres of the EU – EAEU cooperation. The event will bring together representatives of public authorities of the EU and the EAEU, EU business and academic communities.
